Servicemember's Affidavit for Exemption
of Ad Valorem Taxes for Motor Vehicles



Purpose of this affidavit: This affidavit is to be used by a NATO service member to support the service member's or a dependent's exemption from title ad valorem tax (TAVT) on vehicles located in the State of Georgia. A separate affidavit must be submitted for each vehicle or dependent.

How to submit this affidavit: This affidavit must be completed in its entirety, legibly printed in blue or black ink, or typed, and submitted along with all required document(s) to the county tag office in your county of residence. Please refer to https://dor.georgia.gov to locate the county tag office in your county of residence.
