

**GEORGIA SALES AND USE TAX RATES**  
**Prepaid Local Tax Rates (Motor Fuel for Highway Use)**  
**Effective April 1, 2024**

Prepaid local tax is computed by multiplying the jurisdiction's tax rate on sales of motor fuel for highway use, listed below, by the average retail sales price for the applicable type of motor fuel by the number of gallons sold/used. The average retail sales prices are typically published semi-annually at [dor.georgia.gov/calculating-tax-motor-fuel](http://dor.georgia.gov/calculating-tax-motor-fuel).
