The Qualified Law Enforcement Donation Credit Cap for Calendar Year 2025 is \$75,000,000.

For preapprovals processed through the date of this report for Calendar Year 2025, \$2,580,900 of the 2025 Qualified Law Enforcement Donation Credit cap of \$75 million has been used. There is \$72,419,100 remaining in the cap.
