### Secure Power of Attorney for ETR Remote E-signature Solutions



**Purpose of this form:** A seller may use this form when a vehicle is transferred to authorize a purchaser to disclose odometer mileage in lieu of the seller completing the odometer information on the proof of ownership.

**How to submit this form:** This form must be submitted by the person exercising Power(s) of Attorney to secure a Certificate of Title. Failure to do so may result in fines and/or imprisonment. Submit this form electronically along with required documents through the Georgia Department of Revenue - Motor Vehicle Division's Electronic Title and Registration (ETR) program using a remote signature solution.

**Required document:** Completed and signed Form MV-1W Tag/Title Application.
