



## Georgia Department of Revenue Compliance Agreement and Registration Form For Creation of XML Files for Electronic MFD-04 Return Request Submission

An authorized representative of [Vendor Name] must sign this Compliance Agreement in connection with the XML files (herein known as “Agreement”). The Georgia Department of Revenue (herein known as “GADOR”) must receive this Agreement prior to submission of any XML Electronic MFD-04 Return Request(s). All primary and secondary software developers that will create the GADOR XML files in their products must complete this Agreement.

### **SECTION ONE** **Compliance Agreement**

Upon adherence to stipulations set forth below and the GADOR Electronic Schema and test cases, GADOR grants [Vendor Name] permission to produce XML files.

1. Will comply with the development and submission requirements set forth in the GADOR Electronic Schema, and test case documents and this Agreement.
2. Upon receipt of all documents pertaining to Electronic Schema and test cases, will submit Electronic XML MFD Return Request test files to GADOR for compliance review in the manner provided herein.
3. Will notify GADOR, and if necessary, notify and provide customers with updated products, if an error(s) relating to electronic file format, written instructions, or calculations are discovered in any approved product.
4. Will include the Motor Fuel Distributor License number in the Electronic XML MFD-04 Return Request.
5. Grants a limited license to GADOR to display certified software vendors in various GADOR public information venues, material designed only for the purpose of informing tax practitioners and the taxpaying public about software/form developers who have developed XML files in compliance with GADOR’s requirements.
6. By signing this Agreement, [Vendor Name] acknowledges that the XML files produced will not be processed by GADOR if such files do not fully meet the standards set forth in the GADOR Electronic Schema and test cases and this Agreement. GADOR reserves the right to contact this vendor regarding issues of non-compliance.
