Purpose of this Affidavit: This form is to be used by a business owner or executive officer to request the manufacture of Dealer, Distributor and Manufacturer license plates.

How to submit this form: This form must be completed in its entirety, legibly printed or typed, and submitted along with all required documents and fees to the Business Registration Unit of the Motor Vehicle Division. Required document(s): You are required to submit documents supporting State identification numbers, licenses and sale tax; photos of business and signage; copy of land line telephone bill; list of current employees and contractors; copies of current employees and contractors drivers' license; and copies of front and back of title for all sales to out of state or country customers.

INSTRUCTIONS

How to complete the MV-6 Form

COMPLETING this FORM

This form must be completed in its entirety, legibly printed in blue or black ink or typed. **Any correction or alteration will void this form.**

Section A: Complete the business' information. The telephone number must be a publicly listed Georgia telephone number; cell phones are not acceptable. The business address block should contain the physical address of the business.

Section B: Check boxes to indicate the tag category you are requesting. Enter the number of additional plates to be manufactured, if needed, and calculate the total due. The Department's cost to mail must be included in the total due if the plates are to be mailed to the address recorded in Section A.

Section C: Certify that all statements contained in this form are true and accurate.

IMPORTANT INFORMATION

An applicant may only obtain three (3) plates, i.e., one (1) master plate and two (2) additional plates, without completing a MV-6B Dealer, Distributor, Manufacturer or Transporter Application for Additional Tags certifying the number of vehicles that applicant transported during the previous calendar year based on its business records. When recording an actual number, the "Actual Number" box must be checked.

The Department has the right to limit the number of additional plates issued when the numbers certified on the MV-6B Dealer, Distributor, Manufacturer or Transporter Application for Additional Tags differs from the Department's records or investigative findings. The Department may request additional documents to validate the need for additional plates.

Dealer, Manufacturer or Distributor License Plates Can be Used:

- On vehicles in the company's inventory that are being demonstrated to a potential buyer.
- To transport an inventory vehicle from one location to another.
- On dealership, manufacturer or distributor owned vehicles used by officers and employees of the dealership. Employees are defined as persons working for these businesses at least 36 hours per week.

Dealer, Manufacturer or Distributor License Plates Cannot be Used:

- On privately owned vehicles.
- On vehicles for hire or lease.
- On vehicles used in the operations of a dealership, manufacturer or distributor such as rentals, delivery, parts delivery, towing, rollbacks, courtesy, or other manner.
- By friends or family members of employees or officers of the business.

If it is determined that these license plates are unlawfully used, license plates may be revoked and confiscated.

Note: If you go out-of-business, you must turn in all license plates, with a signed letter indicating the reason for the return, to the MVD Business Registration Unit.
