



# Georgia Department of Revenue - Motor Vehicle Division Affidavit of Fact for a Motorcycle or Motor Scooter



**ANY CORRECTION OR ALTERATION WILL VOID THIS AFFIDAVIT**

**Purpose of this affidavit:** This affidavit is to be used by a vehicle owner or selling dealer to obtain a Georgia certificate of title for a motorcycle or motor scooter.

**Completing this affidavit:** This affidavit must be completed in its entirety, legibly printed in blue or black ink.

**Section A:** Complete the owner's/dealer's information.

**Section B:** Record the vehicle information and answer all questions.

**Section C:** Certify before a Notary Public that all statements are true and accurate. If the person completing this form is an individual, please provide driver's license number. If the person completing this form is an authorized agent representing a dealer, please provide the business's/company's customer identification number and the agent's full legal name and position/job title.

**Section D:** Affidavit must be notarized by a commissioned Notary Public.

**How to submit this affidavit:** Submit this completed affidavit along with all required documents to the county tag office. Please refer to <https://dor.georgia.gov> to locate the county tag office in your county of residence or operations.

**Required documents:** You must provide a completed and signed Form MV-1 Title/Tag Application along with a completed and signed Form T-22B Certification of Inspection by a Duly Constituted Georgia Law Enforcement Officer.

**Please note:** If the manufacturer's certificate of origin does not indicate the motorcycle or motor scooter was manufactured for highway use in the United States, it may not be acceptable.
