



Georgia Department of Revenue - Motor Vehicle Division Bus to Motor Home Conversion Affidavit



ANY CORRECTION OR ALTERATION WILL VOID THIS AFFIDAVIT

Purpose of this affidavit: This affidavit is to be used by a motor vehicle owner to request that the registration of a motor vehicle titled with a bus body type to be registered as a motor home.

Completing this affidavit: This affidavit must be completed in its entirety, legibly printed in blue or black ink or typed.

Section A: Complete the owner(s)' information. The mailing address block should contain the physical address of the owner(s).

Section B: Record the vehicle's information.

Section C: Certify before a Notary Public that all statements are true and accurate.

Section D: Affidavit must be notarized by a commissioned Notary Public.

How to submit this affidavit: Submit this completed affidavit along with all required documents to the county tag office at the time of vehicle registration. Please refer to <https://dor.georgia.gov> to locate the county tag office in your county of residence.
