


How to Register as a Software Vendor

This document will show you how to register as a software vendor via GTC. You will need your FEIN and VIN (supplied to you by Georgia Department of Revenue - GDOR). The link to where to register will be sent to you from GDOR.

1. Read the **Requirements and Eligibility** info explaining what you will need in order to apply then click **Next**.

Requirements

What you need

- Federal Employer ID Number (FEIN) and corresponding Vendor Identification Number (VIN).
- A NACTP Vendor ID Number.
- Vendor Code if you submit paper returns.
- An Electronic Filing ID (EFIN) and Electronic Transmitter ID (ETIN) if you are submitting via MeF.
- A phone number that accepts SMS text messages and/or email address for login authentication.


Determine Your Eligibility

- You are a registered Software Vendor.
- You intend to submit electronic or paper returns in Georgia.
