

IMPORTANT INFORMATION

Your Vehicle Registration or Renewal Fees may be affected by the implementation of the Transportation Funding Act of 2015 (HB 170).

ALTERNATIVE FUEL VEHICLES

Alternative Fuel Vehicles are now defined as vehicles fueled solely by electricity, natural gas, propane, bi-fuel, or dual fuel including flex fuel vehicles (such as E-85) and plug-in hybrid-electric vehicles. The term alternative fuel vehicle does not include hybrid-electric vehicles that are not plug-in hybrid-electric vehicles. Vehicles meeting the definition of alternative fuel vehicle are eligible for an alternative fuel vehicle license plate but may opt for another type of plate instead.

Any Alternative Fueled Vehicle, except a vehicle utilizing natural gas or propane, regardless of its type of license plate, will annually be assessed:

Passenger Vehicle	\$200.00 Alternative Fuel Vehicle Registration and Renewal Fee
Commercial Vehicle	\$300.00 Alternative Fuel Vehicle Registration and Renewal Fee

Please Note: Alternative Fuel Vehicle license plate fees (Manufacturing Fee: \$25, Annual Registration Fee: \$20 and Annual Special Tag Fee: \$35) are due in addition to the Alternative Fuel Vehicle registration and renewal fee.

HIGHWAY IMPACT FEES – ALL VEHICLES (OVER 15,500 LBS EXCLUDING IRP REGISTERED VEHICLES)

All vehicles in the following weight classes will annually be assessed:

Vehicle Weights	15,500 lbs to 26,000 lbs	26,001 lbs and over
High Impact Registration and Renewal Fee	\$50.00	\$100.00

Some vehicle owners may be required to provide Gross Vehicle Weight Rating (GVWR) upon registration or renewal. On the vehicle, the GVWR can be found on the door pillar of the driver's side of the vehicle. This can also usually be found with a quick Google search (i.e. 2004 Ford Ranger gross vehicle weight rating).
