



Georgia Department of Revenue - Motor Vehicle Division International Registration Plan (IRP) Certification of Commercial Vehicle License Plate Turn-In



Purpose of this form: This form is to be used by a registrant or motor carrier to certify a reason for turning in a commercial vehicle license plate and cab card.

Completing this form: This form must be completed in its entirety, legibly printed in blue or black ink or typed.

Section A: Record the registrant's IRP account number, fleet number and full legal name.

Section B: Record the vehicle's identification number, year, make, model and the commercial vehicle license plate number registered to the vehicle.

Section C: Certify why the license plate and cab card are being turned in.
