Eligibility Requirements:

- Prior calendar year must have an average amount of sales and use tax attributable to the rental charge of each rental motor vehicle of at least \$400.00.
- 2. Rental Motor Vehicles Sales & Use tax paid towards rentals of 31 days or less.
- Rental Motor Vehicles designated to carry 10 or fewer passengers.
- 4. Rental Motor Vehicles used primarily for the transportation of people.
- 5. Must maintain an average of 5 rental vehicles.

Required Documents:

- 1. Completed MV-15 Rental Certification Affidavit (signed and notarized).
- 2. Completed MV-15 Rental Certification Computation Schedule/ Worksheet.
- 3. Copy of ST-3 Sales & Use Tax Return from prior registration year (Mar 1st Feb 28th)
 - Document must show Confirmation Number.
 - Document must show Sales & Use Number.
 - Document must show as "submitted" as well as reflect the submittal date.
