

Georgia Department of Revenue - Motor Vehicle Division Request for an Inspection of a Rebuilt Motor Vehicle

Purpose of this Form: This form is to be used to request an Inspection of a Rebuilt Motor Vehicle.

How to submit this Form:

- If using a state inspector, mail this completed form to: DOR/Motor Vehicle Division, Attn: Salvage Unit, P. O. Box 740384, Atlanta, Georgia 30374-0384
- If using a private inspector, submit this completed form to the inspector at the time of inspection.

To request an inspection of a Rebuilt Motor Vehicle (choose one):

State inspector take 4-6 weeks to process – no charge for inspection on site

- I understand that it is my responsibility, as the applicant to have the vehicle available for inspection during regular business hours, 8:00am to 4:30pm Monday through Friday, excluding state holidays, unless otherwise instructed by the MVD inspector. If the inspector is unable to reach me or my contact person via phone numbers listed above, MVD will place all received documents on hold and mail a letter telling me to contact the inspection unit.
- Mail this completed form and a check or money order for *document fee to: DOR/Motor Vehicle Division, Attn: Salvage Unit, P.
 O. Box 740384, Atlanta, Georgia 30374-0384

Private inspector are generally completed same day - \$100 inspection fee on site

- I understand that it is my responsibility, as the applicant, to tow (not drive) the vehicle to a Private Inspection Station for same day processing and pay the inspector \$100 inspection fee.
- Take this completed form to the inspection appointment.
- Once the vehicle has passed inspection, mail this completed form and a check or money order for the *document fee to: DOR/Motor Vehicle Division, Attn: Salvage Unit, P. O. Box 740384, Atlanta, Georgia 30374-0384

*Document Fee: A check or money order for \$118 document fee must be included with this application once the vehicle passes inspection (additional charge for assembled: \$50 for vehicle - \$25 for motorcycle)

If this vehicle is eligible for a Georgia title, passes inspection, and all applicable documents with fees have been submitted, please process the issuance of a certificate of title.
