Submitting a Brand Registration

- 1. Go to the GTC website (https://gtc.dor.ga.gov) and log into your account.
- 2. Under the Accounts tab, click the applicable Alcohol License hyperlink.

Submitting a Brand Registration - Broker License

Manufacturers with a broker license must specify which alcohol type they are registering for on Step 3. Only one alcohol type can be chosen for each brand registration submission.
